He has held academic posts as a Professor at the National Institute of Transport (Egypt), King Faisal University (Saudi Arabia). He was also seconded to the Egyptian Military College, Egyptian Traffic Police, the United States Department of Transportation, the Egyptian Environmental Affairs Agency, Department, Civil Engineering Department - Tanta University – Egypt and the United Nations Economic Commission for Africa. Dr Abbas was awarded 2 of the most prestigious fellowships in USA, the first as a Senior Fulbright visiting scholar at University of Texas Austin in 1995 and the second as a Hubert Humphrey fellow at Cornell University in 00/01.

From 2005 to 2008 Dr Abbas was the manager of Transport Planning & Traffic Engineering group at Snowy Mountains Engineering Corporation (SMEC) a lead engineering & development consultancy in Australia. He also held the position of part time Technical Principal at SMEC Australia.
